Sir.

With reference to your letter No.16/1/BBB/20-21/1 dated 28.10.2021 on the above subject, I am directed to say that Biswa Bangla Biswabidyalay, Bolpur, Birbhum, West Bengal - 731 235 has been established w.e.f. 10.12.2020 (Notification No.167L/OM-106L/2020 dated 09.12.2020) by the West Bengal Act XLVII of 2017 (Notification No.23-L.—9th January, 2018) as a State University and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 by conducting courses through its own departments, its constituent colleges and/or through its affiliated colleges in regular mode with the approval of concerned statutory bodies/councils, wherever it is required. The name of the University has been included in the list of universities established as per Section 2(f) of UGC Act. 1956, as maintained by the UGC on its website www.ugc.ac.in.

The University shall operate only within the territorial jurisdiction allotted to it under its Act and in no case beyond the territory of the State of its location. The University is not allowed to start any off-campus centre beyond the territorial jurisdiction as provided in the Act and under no circumstances beyond the State of its location, as per the Hon'ble Supreme Court Judgment in Prof. Yash Pal vs. State of Chhattisgarh case.

The University may note and adhere to the following: -

- To ensure that no off campus centre(s)/study centre(s) is opened beyond the territorial jurisdiction of the University as stipulated in the Act and in no case beyond the territory of the State.
- To ensure that no programmes should be offered through franchising arrangement with private institutions.
- (iii) To ensure that no study centre(s) are opened through franchises by the University.
- (iv) In case the university has already started any off-campus/study centre and the centre operating through franchises outside the State, it must be closed immediately.

- (v) No Open and Distance Learning Programme land on-line programmes shall be started without the prior recognition of UGC. Relevant UGC Regulations are available on the UGC website <a href="https://www.ugc.ac.in">www.ugc.ac.in</a>.
- (vi) M.Phil/Ph.Dprogrammes can be conducted as per the provisions of UGC (Minimum Standards and Procedure for Awards of M.Phil/Ph.D. Degree) Regulations, 2016.
- (vii) The University is required to follow all the UGC Regulations notified and available on UGC website www.ugc.ac.in.
