

National Sports University, Manipur, established under an Act of Parliament viz., National Sports University Act 2018, is running a 4 Years (Eight Semester) B.Sc. (Sports Coaching) Course, among other courses. National Sports University is the first of its kind, to promote sports education in the areas of sports sciences, sports technology, sports management and sports coaching besides functioning as the national training centre for select sports disciplines by adopting best international practices.

2. 4 Years ( Eight Semesters) B.Sc. (Sports Coaching) programme of National Sports University is at par with or equivalent to Post graduate Diploma Courses in Sports Coaching, being offered by Netaji Subhash National Institute of Sports (NSNIS), Patiala or Lakshmbai National Institute of Physical Education (LNIPE), Gwalior.

3. The matter has been considered in the Ministry and after consideration it has been decided to treat the 4 Years ( Eight Semesters) B.Sc. (Sports Coaching) programme offered by National Sports University, Manipur at par with or equivalent to Post Graduate Diploma courses in Sports Coaching, offered by Netaji Subhash National Institute of Sports (NSNIS), Patiala or Lakshmbai National Institute of Physical Education (LNIPE), Gwalior, for recruitment of coaches by the various organizations under the Central Government, State Governments/UT and others.
