NOTIFICATION

WHEREAS Biswa Bangla Biswabidyalay, a State-aided University, was established and incorporated by and under the Biswa Bangla Biswabidyalay Act, 2017;

AND WHEREAS, there are no permanent Registrar and Controller of Examinations in the said University and thereby causing hindrance in the functioning of the University;


AND WHEREAS, Vice-Chancellor (Authorized), Biswa Bangla Biswabidyalay has sent a proposal to accord approval towards engagement of Dr. Mangilal Taparia, Associate Professor of Commerce, Suri Vidyasagar College, Suri, Birbhum, as the Registrar and Dr. Prasun Banerjee, Associate Professor of English, Kabi Joydeb Mahavidyalaya, Illambazar, Birbhum, as the Controller of Examinations of the University w. e. f. December, 2023;

AND WHEREAS, considering the urgency in this regard and to ensure smooth academic and administrative functioning of the University and also considering the interest of the students already admitted in the University, the State Government, being duty bound to ensure the welfare of the State, feels it necessary to appoint suitable persons to act as the Registrar and the Controller of Examinations;

NOW, THEREFORE, in larger public interest and in exercise of the powers under Section 64 of the Biswa Bangla Biswabidyalay Act, 2017 read with Section 18 of the West Bengal Universities and Colleges (Administration and Regulation) Act, 2017, the Governor is pleased to direct Dr. Mangilal Taparia, Associate Professor of Commerce, Suri Vidyasagar College, Suri, Birbhum to act as the Registrar and Dr. Prasun Banerjee, Associate Professor of English, Kabi Joydeb Mahavidyalaya, Illambazar, Birbhum to act as the Controller of Examinations of Biswa Bangla Biswabidyalay respectively with effect from December, 2023

in addition to their normal duties till the regular appointment of Registrar, Controller of Examinations of the University or until further orders, whichever is earlier.
